Graduated in law at Washington and Lee College. Went overseas in World War I. Commonwealth Attorney of Appomattox County 1918 to 1932. Elected to Congress to fill out the term of the late Harry St. George Tucker. Assistant Attorney General of the State to help prosecute violators of the 18th Amendment. At present Judge of this Judicial Circuit (1948).
